

ENSURE MAX POWERED BY PROTEIN MAX CHALLENGE SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The Ensure Max Powered by Protein Max Challenge Sweepstakes (“Sweepstakes”) is sponsored by Abbott Laboratories Inc. (“Sponsor”), 100 Abbott Park Road, Abbott Park, IL 60064, and is administered by Prize Logic, LLC, (“Administrator”), Two Towne Square, Suite 200, Southfield, MI 48076.

Non-winning entries will carry forward into subsequent Entry Periods. The Administrator’s computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of one of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. NOTE: During the Sweepstakes Period, an entrant may receive a link to the Website by scanning the QR code on select print advertising. An entrant may center the QR code in the camera and scan the QR code. Once completed, the entrant will receive a link to the Website, and may follow the steps noted above to enter the Sweepstakes. **An entrant cannot participate solely by scanning the QR code.**

Entry Limit: There is a limit of one (1) entry per person per day.
